12/14/56 Pressur up for water shut off. Found O.K.
Perf with jet gun 4 shots to foot at 4034 - 4046, treated 10,000 Gal oil, 10,000 # sand, 250 Gal MSA Acid. Set Bridge plug 3780'. Perf with jet gun, four shots to foot from 3754-3770. Pressured up on pipe for treatment. Pipe split at 944'.

12/16/56 Ran Squeeze job using 350 sx cement, circulating to surface. Let set 72 hours. Tested and found O.K.

1/4/57 Perf 3690-3710 4 shot per ft., Frac with 9000 gal oil, 10,000# sand, 250 Acid.
1/11/57 Squeeze off from 3690-3710 with 200 sx cement.
1/14/57 Set squeeze packer 3627 with 200 sx rag. next.
1/31/57 set 4 1/2" packer at 4017 to treat 4034-4046 with perflo 25 gal, 2100 gal treated oil and 50 BPL crude.
Shut down, capped, awaiting orders from head office.
