1. Pump 50 sack cement plug to bottom through 2" EUE tubing using 10# mud to displace with. Fill up 50'.
2. Fill hole with 10# mud.
3. Spot 25 sack cement plug at 875 (bottom of 8-5/8").
4. Put 5 sack cement plug and 4" pipe marker in top of 8-5/8" casing. Fill up 14'.
