Spudded 11" hole 7-6-60. On 7-7-60 8-5/8" OD 22.7# SJ Armo Casing was run and set at 755' with 450 SK cement. Cement Circulated. After WOC 18 hours tested casing with 600 PSI for 30 minutes with no loss in pressure. Reduced hole to 7-7/8" at 755' and resumed drilling operations.
