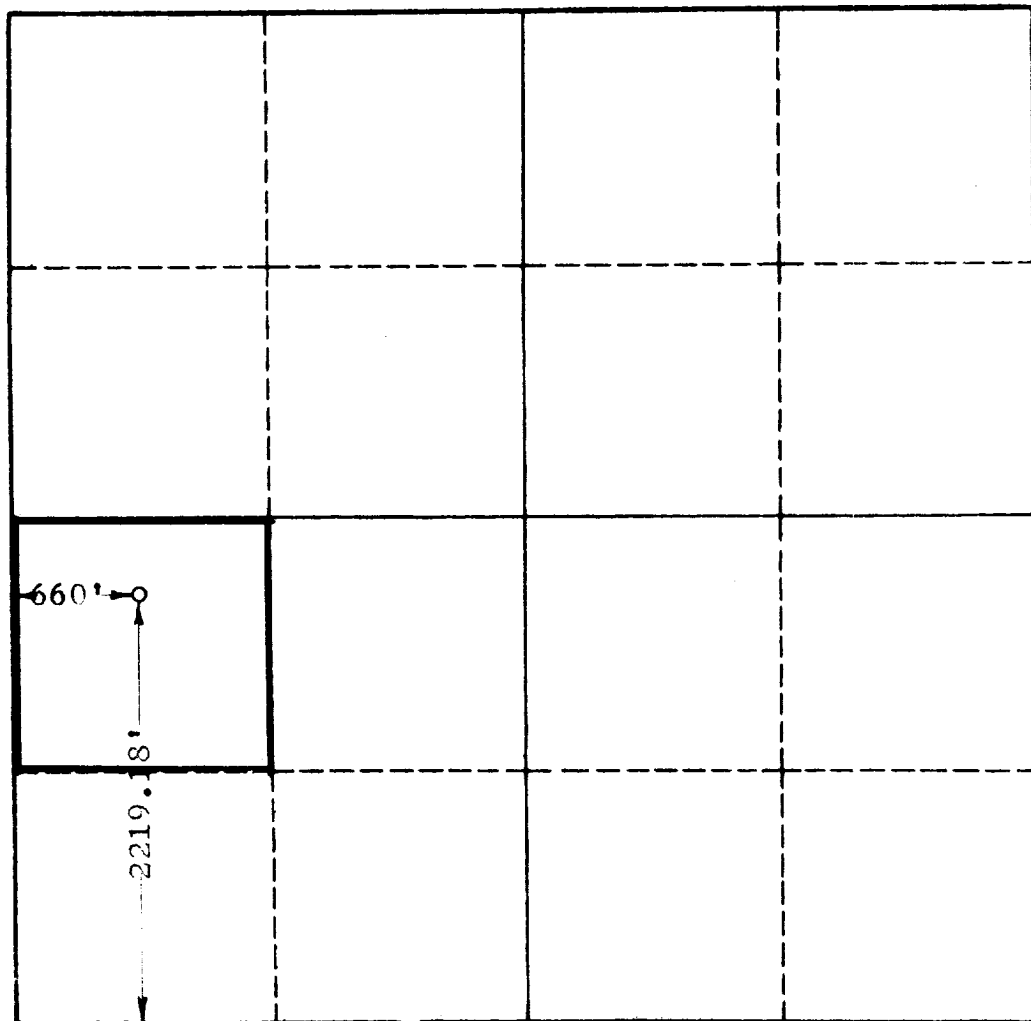

Gentlemen:

On November 17, 1959, a survey was made to locate your State "BB" Well No. 4 at a point 2219.18 feet from the South line and 660 feet from the West line of Section 6, Twp. 18 S., Rng. 28 E., N.M.P.M., Eddy County, New Mexico. Said well also described as being 330 feet from the North line and 660 feet from the West line of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of said Section 6.

A flag was set up at the USGLO Quarter Section corner marker common to Section 6 and Section 1, Rng. 27 E. The transit was set up at the USGLO Section corner marker common to Sections 6 and 7, Twp. 18 S., Rng. 28 E., and Sections 1 and 12, Twp. 18 S., Rng. 27 E. Thence chaining from the transit N 0° 03' E along the West line of Section 6 a distance of 2219.18 feet; thence N 89° 50' E a distance of 660 feet to the location site of the State "BB" Well No. 4. As a check on our survey we chained S 89° 50' W a distance of 660 feet and N 0° 03' E a distance of 322.2 feet to the USGLO Quarter Section corner marker common to Section 6 and Section 1, Rng. 27 E. checking in within 0.40 feet of the distance shown on the USGLO Township Plats.
