

A 12 $\frac{1}{2}$ " hole was spudded 12-27-59. On 12-29-59 8 5/8" OD 22.7# Arnco casing was run and set at 1003 W/550 ex. cement circulated. After WOC 24 hours tested casing with 400 PSI for 30 minutes with no loss in pressure. Reduced hole 7 7/8" and resumed drilling operations.

Note: The surface casing program was changed to the above since location is outside water basin.
