Detailed account of work done, nature and quantity of materials used, and results obtained.

Drilled well to 2080' w/ cable tools. Set 10 3/4" @ 390'. Set 8 5/8" @ 975'. After setting 8 5/8" pulled all 10 3/4". After reaching T. B. of 2080', pulled 468' of 8 5/8" leaving shoe @ 507'. Cemented w/ 200 sacks. Did not circulate. Changed rigs putting on rotary. Ran 1" pipe outside 8 5/8" to 315'. Cemented w/ total 250 sacks - two 25 sack stages - one 50 sack stage after which we had fill-up back to 265'. Then cemented down 1" w/ 150 sacks which circulated cement to top of hole. Before drilling plug pressured to 800 p.s.i. Held o.k. Drilled plug to 510' and pressured to 800 p.s.i. Held o.k. After cementing and before conducting pressure tests as above described, we let cement set for 18 hours.
