Propose to plug and abandon as follows:

- TOOH with 2-7/8" tubing.
- Set CIBP at 2640'. * TIH and tag CIBP. Load hole with plugging mud.
- Spot a 30 sack Class C cement plug from 2640-2470'. TOOH with tubing.
- Perforate 7" casing with 6 holes at 1090' and 6 holes at 465'. 345'
- TIH with wireline set cement retainer and set retainer at 1000'. TOOH. Load hole with plugging mud. Establish an injection rate. Squeeze with 75 sacks Class C cement. Leave 35' of cement on top of retainer. TOOH with tubing.
- TIH with wireline set cement retainer and set retainer at 365'. TOOH. Establish circulation. Squeeze with 60 sacks Class C cement from 465-365'. Leave 35' of cement on top of retainer. TOOH with tubing.
- Spot a 15 sack Class C cement plug at surface.
- Install regulation abandonment marker.

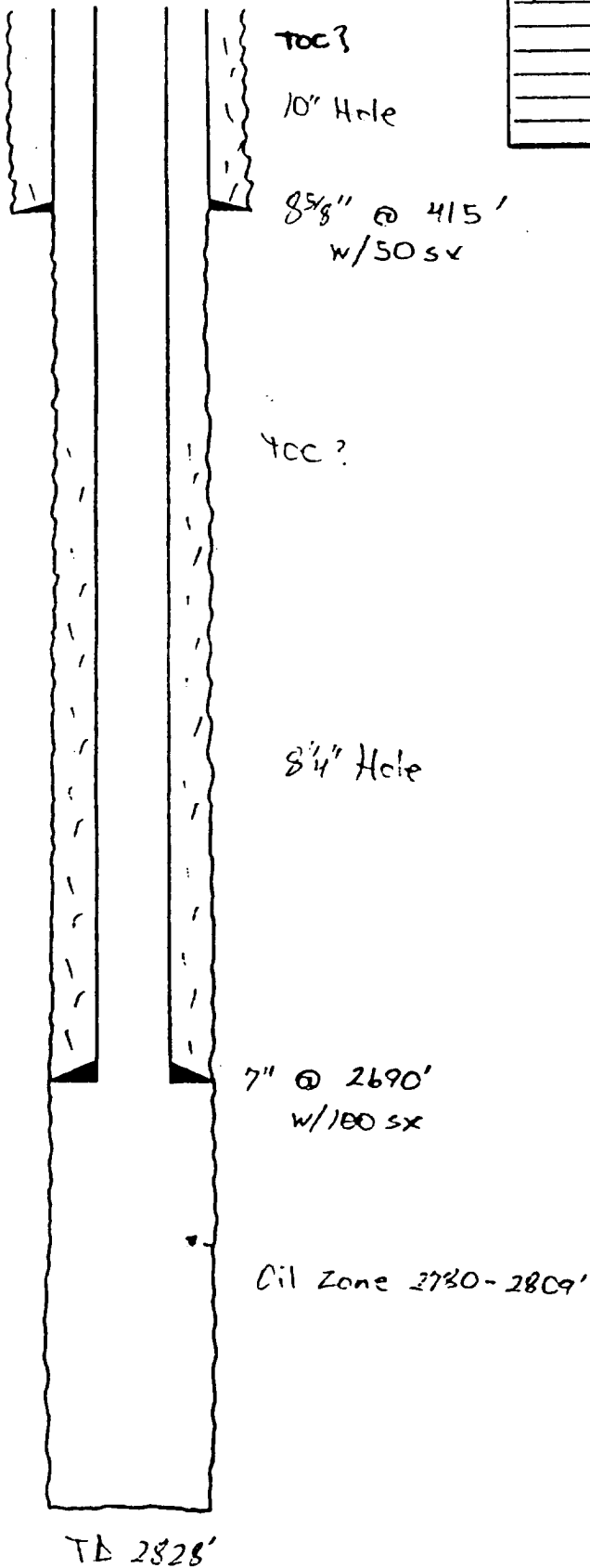

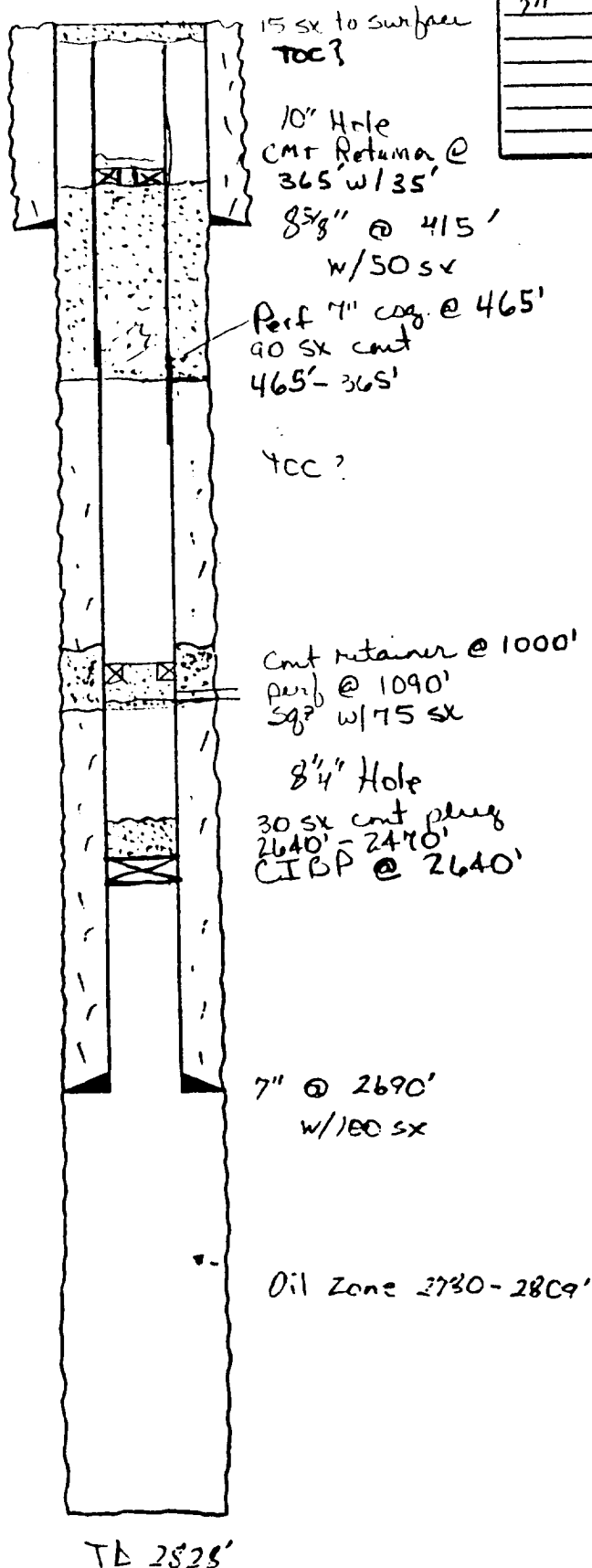
