Propose to plug well as follows:

1. Spot sufficient cement across producing interval to tie back 50' into production casing shoe. Tag plug.
2. Isolate Queen formation from overlying zones with 100' cement plug. Top of Queen is at 2235'; top of cement is at 1813'.
3. Perforate 50' below base of salt at 1185' and squeeze with 50 sx cement, leaving 100' plug in casing. Tag plug.
4. Perforate 50' above top of salt at 355' and squeeze with 50 sx cement, leaving 100' plug in casing. Tag plug.
5. Set 50' surface both sides of csg. plug and install regulation abandonment marker.

NOTE: 1) NOTIFY BLM, CARLSBAD, NM, (887-6544) 24 HOURS PRIOR TO BEGINNING WORK.

2) Mud between plugs to be 10#/gallon mud-laden fluid.
