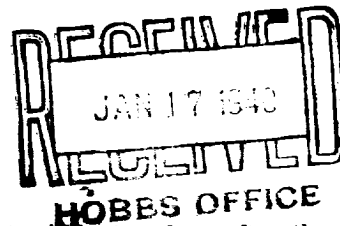

It should be signed and sworn to before a notary public for reports on beginning drilling operations, results of shooting well, results of test of casing shut-offs, result of plugging of well, and other important operations, even though the work was witnessed by an agent of the commission. Reports on minor operations need not be signed and sworn to before a notary public. See additional instructions in the Rules and Regulations of the Commission.

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On January 14, set 440 ft. of 8" salt string approximately 21 ft. below the top of salt with the Halliburton process, cementing with 50 sacks of cement. Permitted the cement to set for 72 hours in order to test cement and water shut-off, then bailed the hole dry. Drilled cement plug and bailed hole dry again and let set for one hour before testing water shut-off. Result--complete water shut-off. Resumed drilling operations.
