Well was cleaned out to the total depth of 2653 and 2½ tubing ran to 2651. Hole was loaded with 1500 gals of Kero and 20 gals of DOWELL P-4 Solvent.

Well treated March 28, 1955 with 10,000 gals of heavy oil and 20,000 lbs of sand.

Well returned to production March 30, 1955 and is presently making 16.56 bbls daily
