On or about May 26, 1947, we plan to plug and abandon this well for it is pumping only 1 1/2 bbls. oil per day with 80% salt water. 3" oil string is set at 2523'. Plan to shoot off 7" pipe at approximately 1900' and pull this pipe. Plan to leave 8 1/4" surface cemented at 453', plan to fill hole with 15' cement plug on top of pay zone, and fill hole to surface with mud, with cement plug and 4" pipe marker at surface.
