DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Hole was filled with mud and a 10 sack cement plug was dumped on bridge set in open hole at 2475', this plug extending up into the 7" casing. The 7" casing was knocked off and pulled at 804'. A 10 sack cement plug was dumped on bridge set at 840' near base of salt and extending up over top of 7" pipe left in hole. The 8" pipe was knocked off and pulled at 183' and a 10 sack cement plug was dumped on bridge at 445' set just below bottom of 8" casing shoe. Hole was filled with mud between plugs. Cement plug and pipe marker was placed at base of 5' collar and collar filled to surface.
