1. Rigged up pulling unit, pulled rods and tubing.

2. Reversed out fillup from 3028 to TD - 3054'.

3. Ran Compensated Neutron Log.

4. Perforated Premier Zone: 2698, 2708, 2674-82, 2666-72, 2644-50, 2630-34, 2618-22 & 2596-2602 @ 2SPF.
Perforated Metex Zone: 2546-50, 2528-36, 2511-15 & 2490-98 @ 2 SPF.

5. Set packer @ 2744', acidized with 50 bbls 15% NE acid. Acidized 2744-2565 (Premier) with 44 bbls of 15% NE acid & 176 BS, overflushed with 50 bbls fresh water. Acidized 2565-2498 (Metex) with 24 bbls 15% NE acid and 96 BS, overflushed with 50 bbls fresh water.

6. Fraced Metex & Premier Zones 2744-2498 in 5 equal stages with a total of 1250 gals 15% NE acid, 75,000 gals gelled fresh water, 30,000# 100 Mesh sand, 42,500# 20/40 sand, 15,000# 10/20 sand & 250# Gypam. Average rate = 20 BM @ 2680#.

7. Washed frac sand out to TD. Ran 2-3/8" tubing, set SNOE @ 3030'. Ran pump & rods. Returned well to production.

Note: 2 copies of log accompanying this report.

Production prior to workover = 9 BO + 8 BWPD.

Production after workover = 71 BO + 51 BLW + 9100 cu. ft. gas.

Gravity = 38.9° @ 60°F, GOR = 128:1

Instructions
