1. Pumped 200 bbls. Halliburton Injctrol G down 2 3/8" injection tubing, flushed w/8 bbls. Temblock 50; shut well in to let Injctrol complex.
2. Rigged up pulling unit, unseated and pulled injection packer and tubing.
3. Sand drilled O. H. 2464-2490.
4. Cleaned out to T. D. 2508.
5. Ran 2 3/8" plastic lined tubing.
6. Loaded casing annulus with fresh water and chemical.
7. Returned well to injection.
