1. Pulled and laid down rods and tubing.
2. Ran 7" Guiberson injection packer on 75 joints of 2 3/8" internally plastic coated tubing.
3. Loaded casing annulus with chemical water.
4. Set injection packer @ 2300'.
5. Installed a 1/2" needle valve on casing. Valve is to be left open to monitor any leak which might develop downhole.
6. Commenced water injection 10-16-75 in accordance with Administrative Order WFX No. 425.
