DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

After setting 2525 ft. of 7" O.D. (20 lb. seamless pipe) with 5 tons of mud and 100 sacks of cement, let same set for 72 hours, the hole was bailed dry--cement plug drilled out and hole bailed dry again--let hole set one hour and re-bailed, -- Result, complete water shut-off. Resumed drilling operations.
