A field inspection conducted on 9/27/2002 at the WLHU TRACT 28 #3 found the P&A location To contain uncorrected hydrocarbon contamination.

This referred to hydrocarbon contamination at the WLHU TR. 28 #3 is in violation of Rule 116.D. CORRECTIVE ACTION. The responsible person must complete division approved corrective action For releases which endanger public health or the enviroment. Releases will be addressed in accordance With a remediation plan submitted to and approved by the Division or and abatement plan submitted in Accordance with rule 19. {19 NMAC 15.A.19}

The well bonding for the WLHU Tr. 28 #3 will not be released until A corrective action work plan is submitted and approved by N.M.O.C.D., Remediation actions have taken place to correct the referred to hydrocarbon contamination at the WLHU 28 #3, And a subsequent report has been filled and submitted to N.M.O.C.D. using form C-103. subsequent report of corrective actions taken.

A work plan to correct the referred to hydrocarbon contamination at the WLHU Tr. 28 #3 shall be submitted by 10/31/2002 to N.M.O.C.D. for approval.

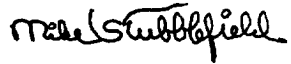
