3-30-2000 - Moved in and rigged up pulling unit. TOOH with rods and tubing. Tubing was parted. TIH with fishing tools and tubing and latched onto fish. TOOH partway. Shut down for night.

3-31-2000 - Finished TOOH with fish. Fish was only 5 joints. TIH with fishing tool. Cannot fish. BLM agreed that we are deep enough. TOH with tubing. Rigged down and moved out pulling unit.

4-1-2000 - Break off wellhead. Moved in and rigged up coiled tubing unit. Rigged up wireline. TIH with CIBP and tagged fish at 2473'. Pulled up and set CIBP at 2471'. TOOH with wireline. TIH with 1-1/2" coiled tubing and tagged CIBP at 2471'. Set a 30 sack Class C cement plug from 2471-2297'. POOH with wireline. TIH with wireline. Perforated 6 holes at 1100'. TOOH. RIH with wireline. Perforated 6 holes at 360'. TOOH. TIH with cement retainer on wireline and set retainer at 1050'. POOH with wireline. TIH with coiled tubing and sting into retainer. Pumped to 1000 psi, holding OK. POOH. Spotted 20 sacks Class C cement on top of retainer. POOH with coiled tubing.
