After setting 2573 feet 6 inches of 7" C.B. Casing (22 lb. seamless) and cementing with 100 sacks of cement and 5 tons mud, let set for 72 hours, the hole was bailed dry - cement plug drilled out and hole bailed dry again. Let hole set for one hour and rebailed, result, complete water shut off. Resumed operations.
