9-23-65 Run tool and sandrill using 10/20 sand for 30 minutes each spot at 2715-2712-2708-2704. Circulate hole clean to 2734.

9-24-65 Check TD at 2732'; pull tubing and jet tool.

9-25-65 Dump 12 gallons Calseal under 300# pressure and let set 2 hours; check TD 2734'. Dump 12 gallons Hydromite under 300# pressure; check TD at 2719'. Shut down 24 hours.

9-26-65 Return well to injection.

Injection first five days averaged 500 BPD
