Propose to P/A well as follows(Well diagram attached):

- (a) Set cmt. sq. ret. in 7" approx. 30' above the Loco Hills Perfs and squeeze the open-hole and the perfs. Estimate 75-150 sx. to squeeze. Place 100' cmt. plug over the cmt. sq. ret.
- (b) Perf. approx. 30' above the G/B top and squeeze with approx. 50-sxs. Place 100' cmt. plug over the cmt. sq. ret.
- (c) Perf. at approx. 1800'(between Qn & 7-Rvrs Tops) and squeeze with approx. 50-sxs. Place 100' cmt. plug over the cmt. sq. ret.
- (d) Perf. approx. 30' below the base of the salt and squeeze with approx. 50-sxs. Place 100' cmt. plug over the cmt. sq. ret.
- (e) Perf. the 7" at approx. 330' and circ. cmt. behind the 7" to the surface.
- (f) Place 10-sx. plug in 7" at surface
- (g) Restore location and notify BLM-Carlsbad
- (h) Notify BLM-Carlsbad 24-Hrs. in advance of commencing

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
