Detailed account of work done, nature and quantity of materials used, and results obtained.

Re-entered old hole on December 4, 1963. Cleaned out to a depth of 2550' and lost tools in hole. Plugged and abandoned well, in accordance with verbal approval of the Oil Conservation Commission representative, as follows: Ran tubing to 1100' and filled hole with heavy gel. Spotted 20 sack cement plug at base of salt at 950'. Also spotted 20 sack cement plug at top of salt at 475'. Set regulation marker in 10 sack cement plug at surface.

Ran into junk in the hole and lost a string of drilling tools. Also lost a string of fishing tools and about 2200' of wire line in the hole.
