Spudded on re-entry October 6, 1972. Set 8 5/8" casing at 346', cemented with 250 sacks Class H, 2% CaCl. Let cement set 18 hours and tested to 500 PSI. Washed well down to 3100' and drilled new hole to 3332'. Ran logs. Ran 5 1/2" casing to 3305', cemented with 500 sacks Class C Pozmix on October 12, 1972.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
