DETAILS OF WORK

Intend to drill with rotary tool to test the Grayburg Formation expected to be penetrated at approximately 2500 feet. Will set 7" OD 17# casing at approximately 400" and cement same with 75 sac cement. If completion is attempted, will run 4 1/2" OD 9.5# new casing to approximately total depth and cement same with 100 sac cement. Intend to abide by the rules and regulations of the department.

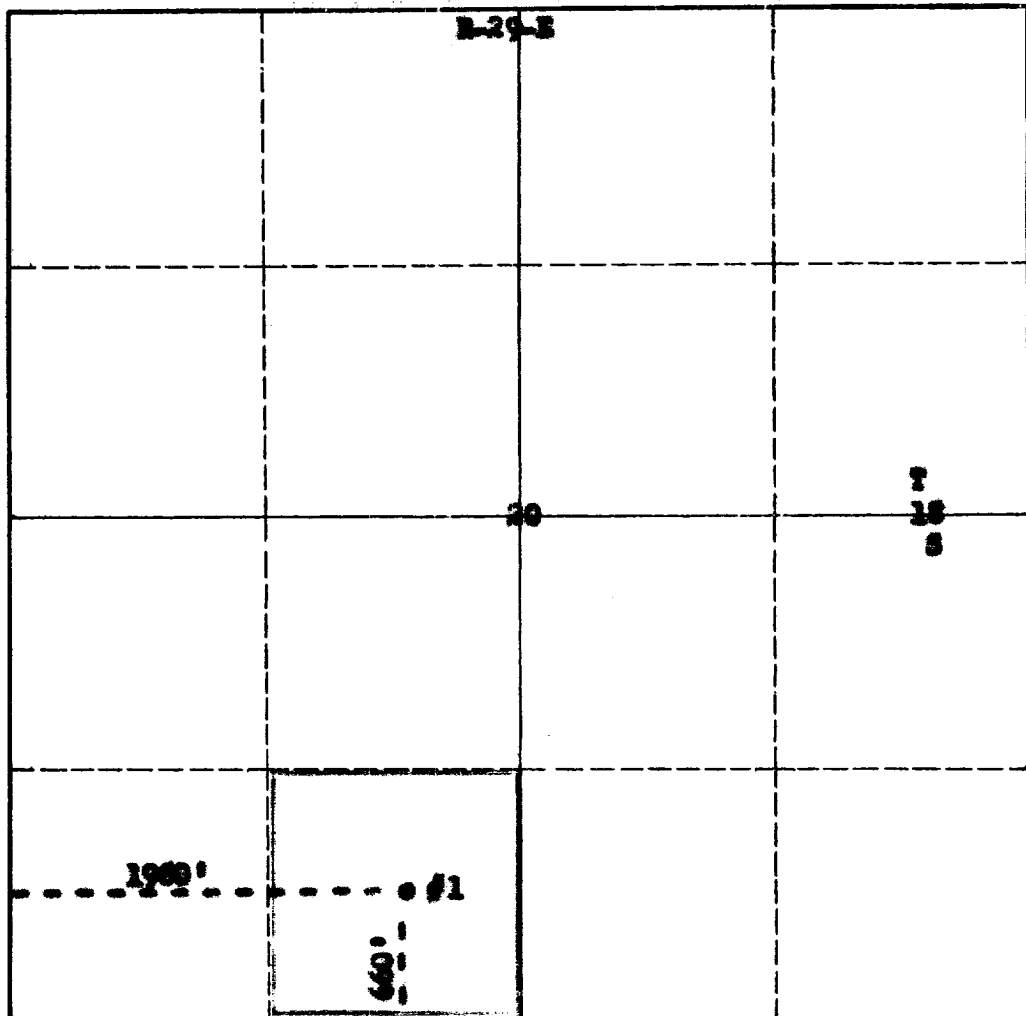
