NOTIFY BLM IN CARLSBAD 24 HOURS BEFORE STARTING PLUGGING OPERATIONS.

1. MIRU WSU & safety equipment. No casing recovery will be attempted; POH w/ tubing if any.
2. TIH w/ tubing to tag CIBP @ +/- 2655'. If it exists, cap w/ 35' of cement. If CIBP is not present, RU WL to set CIBP @ 2655', TOH. TIH w/ tubing to tag CIBP. Load hole w/ plugging mud; spot 35' Class C cement on top of CIBP.
3. TOH w/ tubing. MIRU WL to perf 7" casing w/ casing guns 4 shots @ 1214' & at 505'.
4. TIH w/ WL, set cement retainer @ 1114' - TOH. TIH w/ tubing, load hole w/ mud, sting into retainer & establish injection rate. Squeeze w/ 75 sx Class C cement w/ 5#/sx salt. Leave 35' of cement on top of retainer; TOH w/ tubing.
5. TIH w/ WL; set cement retainer @ 375', TOH. ND BOP's; TIH w/ tubing, load hole w/ mud. Sting into retainer & establish circ. Squeeze w/ 100 sx Class C cement w/ 5#/sx salt from 505 to near surface; leave 35' of cement on retainer. TOH w/ tubing.
6. Spot 15 sk Class C cement plug @ surface.
7. Remove all surface equipment & weld dry hole marker per regulations.
