10-10-2002 - Moved in and rigged up pulling unit and plugging equipment. Installed 7" casinghead. Nippled up BOP. Rigged up floor and 2-3/8" tubing equipment. RIH with tubing and stopped at 45'. POOH with tubing. Shut well in for night.  
10-11-2002 - RIH and tagged at 45'. Loaded hole with fresh water. Turned with tongs. Went down to 120'. Filled hole with fresh water. Shut well in for night.  
10-12-14-2002 - Rigged up reverse unit equipment. RIH with bit and collars and started drilling at 120'. Drilled to 450' and bit stuck. Worked pipe. Shut well in for night.  
10-15-2002 - Worked tubing. Backed off at drill collars. POOH with tubing. RIH with wash pipe and washed over collars to bit. POOH with wash pipe. RIH with overshot and latched onto collars and worked loose. POOH with collars. Shut well in for night.  
10-16-2002 - RIH with bit, collars and tubing and started drilling at 450'. Drilled to 600' and lost circulation. POOH with bit - collars plugged. RIH with tubing open ended to 740'. POOH with 1 joint. Shut well in for night.  
10-17-2002 - Mixed LCM and circulated hole with LCM. POOH with tubing. RIH with bit
