This well was temporarily abandoned January 27, 1959 at TD 2941'. The hole was filled with heavy mud. The 8-5/8" casing was set at 471' with 50 sacks cement. On or about October 30, 1974 we plan to plug and abandon the well as follows:

Run 2" tubing to TD and spot 25 sacks plug 2941'-2841' across Loco Hills Sand  
25 sacks plug 1250'-1150' at Base of Salt  
25 sacks plug 500'-400' in and out of 8-5/8" csg.  
10 sacks plug and marker at surface.
