Plan to open well May 16 1959 and drill to and set approx. 900' of 8 5/8" C.D. 2 1/2" new seamless casing cementing with 50 sacks cement and 50 sacks mud. After cement sets 72 hrs. will drill cement plug and test for water shutoff. Plan to drill to and set approx. 2875' of 7" C.D. 20" new seamless casing cementing with 100 sacks cement and 100 sacks mud. Plan to complete well in the Loce Hills sand at approx. 2900'. Plan to drill well from top to bottom with cable tools.

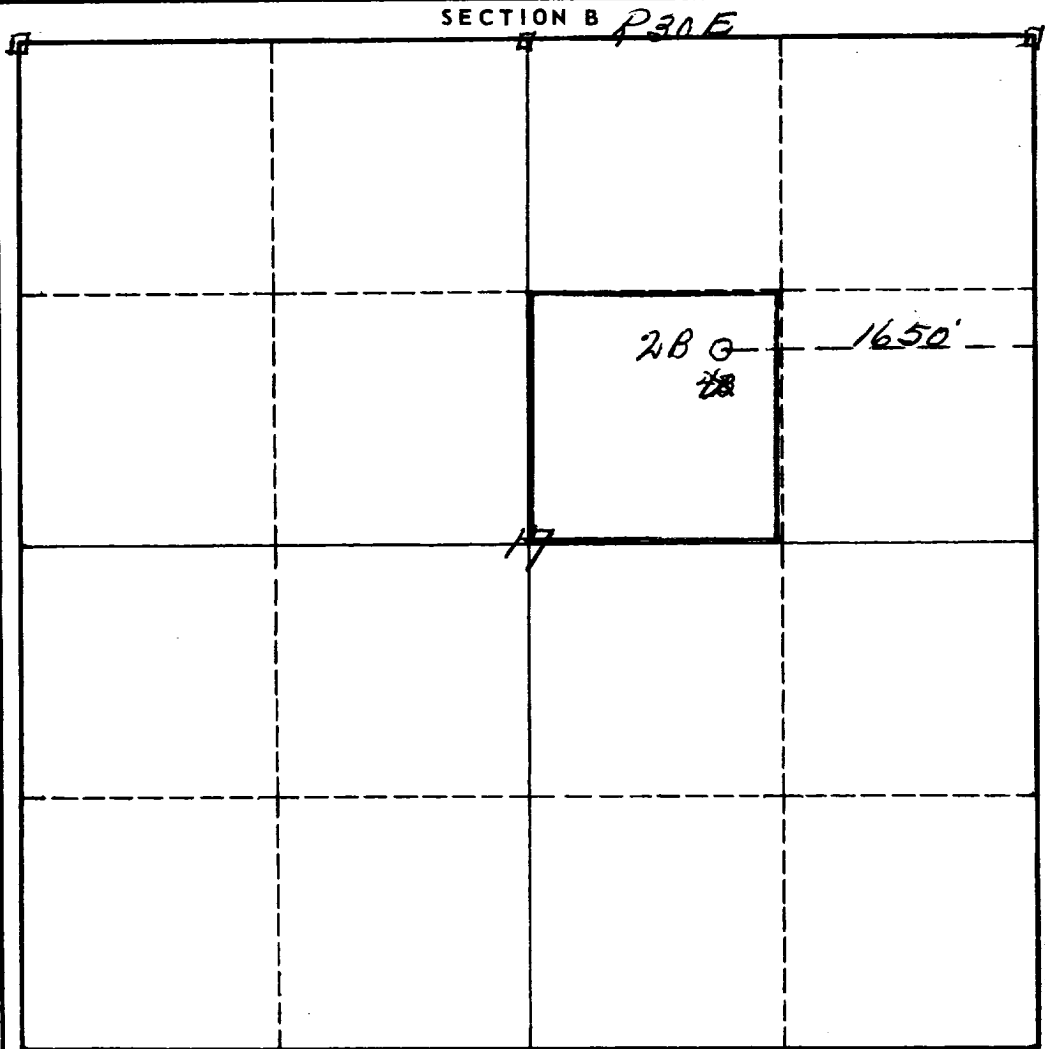
