We propose to re-enter and clean out to a depth of 2550' to test Lower Yates sand. If production we will run 2550' of 5 1/2" csg. for oil string and cement w/100 sacks.

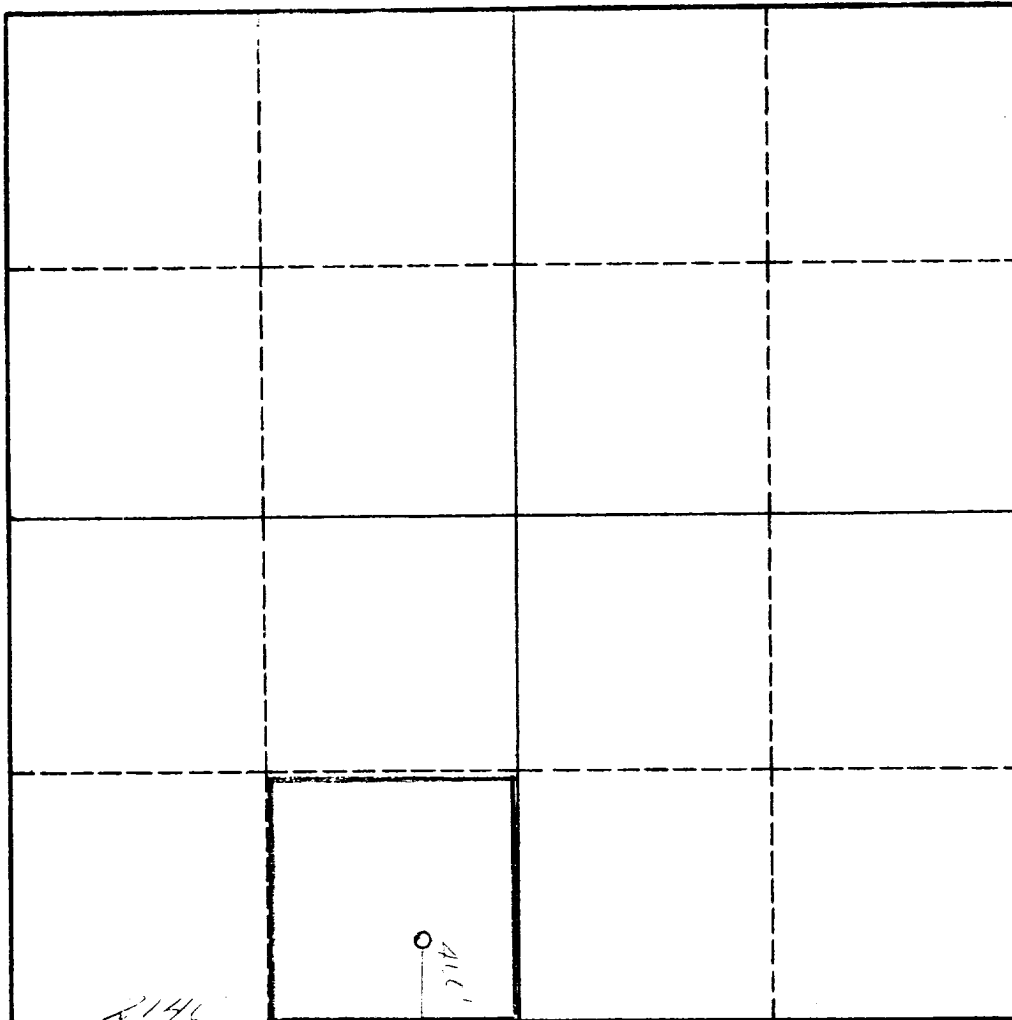
