This well is pumping 12 barrels of oil plus 28 barrels of water per day.

We propose to run a gamma ray-neutron log and caliper survey. We will then frac the 9th zone with 10,000 gallons of Redi-frac plus 8,000# of sand with Sinclair S-9 scale preventer chemical ahead of frac. The 7th zone will then be given the same treatment. Control of treatments will be accomplished using a Lyness packer on 3 1/2" O.D. tubing.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
