On Nov. 20, 1972, a Lynes packer was run on 2½" tubing and set at 3870'. Broke down below packer at 3000 psi. at 7 BPM. Treated with 200 gallons acid w/2 gals. Protex; 1,000 gals. gel pad, 3,300 gals. HAL-4033 gel, 3,600 gals. MOD-202 acid containing 36 gals. Protex. Treated at 8 BPM at 3000 psi. to 2800 psi. After recovering load, well pumped 12 BO + 55 BWPD, no improvement over previous tests.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
