A few weeks ago, this well developed a high pressure water flow indicating 7" casing had collapsed. An attempt was made to exhaust the flow but the flow levelled off at about 1500 barrels per day. Shut-in pressure was 1820 psi. on Oct. 12, 1977. Verbal approval was obtained from Mr. Knauf to attempt to recover 900' of tubing in hole, swage out 7" casing, run and cement 4 1/2" casing. This will be attempted.
