This well is pumping approximately 8 BO + 10 BWPD. It is proposed to set a Lynes packer at about 3886' and acidize below with two stages of 3,000 gallons of Mighty Gel + 2,500 gallons of MOD-202 acid containing 25 gallons of Protex (scale inhibitor) in each stage. A plug of TLC-80 will be used to separate stages.

Instructions
