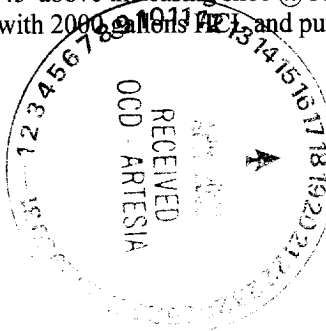

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zone. We plan to set an injection packer in the 7" @ 3245', 45' above the casing shoe @ 3390', using 2 3/8" plastic coated tubing. We will acidize the open hole interval from 3291' - 3895' with 200 gallons of 12% HCl and put the well on injection.
