Perforations at 3830'-3910' were acidized on Feb. 23, 1968, below a packer set at 3810', with 1,000 gallons of 28% Superacid. Well treated at 2200 psi. with injection rate starting at 1 BPM and ending at 2.4 BPM. On Feb. 25, Zone 9 took 478 barrels of water at 1895 psi.

Instructions
