To convert this well to a water injection well, we propose to dump 20 barrels of hot water down casing and pump this out. We will clean out to 3907' and set plastic coated tubing at 3774'. Water injection will then be started.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
