PBTD 3908'. On June 4, 1974, perforated $\frac{3}{4}$ " casing from 3907 to 3898' with 2 shots/ft. Set packer at 3882'. Attempted to acidize 3907-3898 but formation wouldn't take acid at 4200 psi. Left acid on formation.

On June 5, 1974, attempted to acidize but communicated with perfs at 3870 at 4500 psi. Unable to get a good acid job. There is no improvement in injectivity.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
