We will drill with cable tools to a depth of approximately 4,000 feet to test the San Andres Formation, and complete the well through perforations.

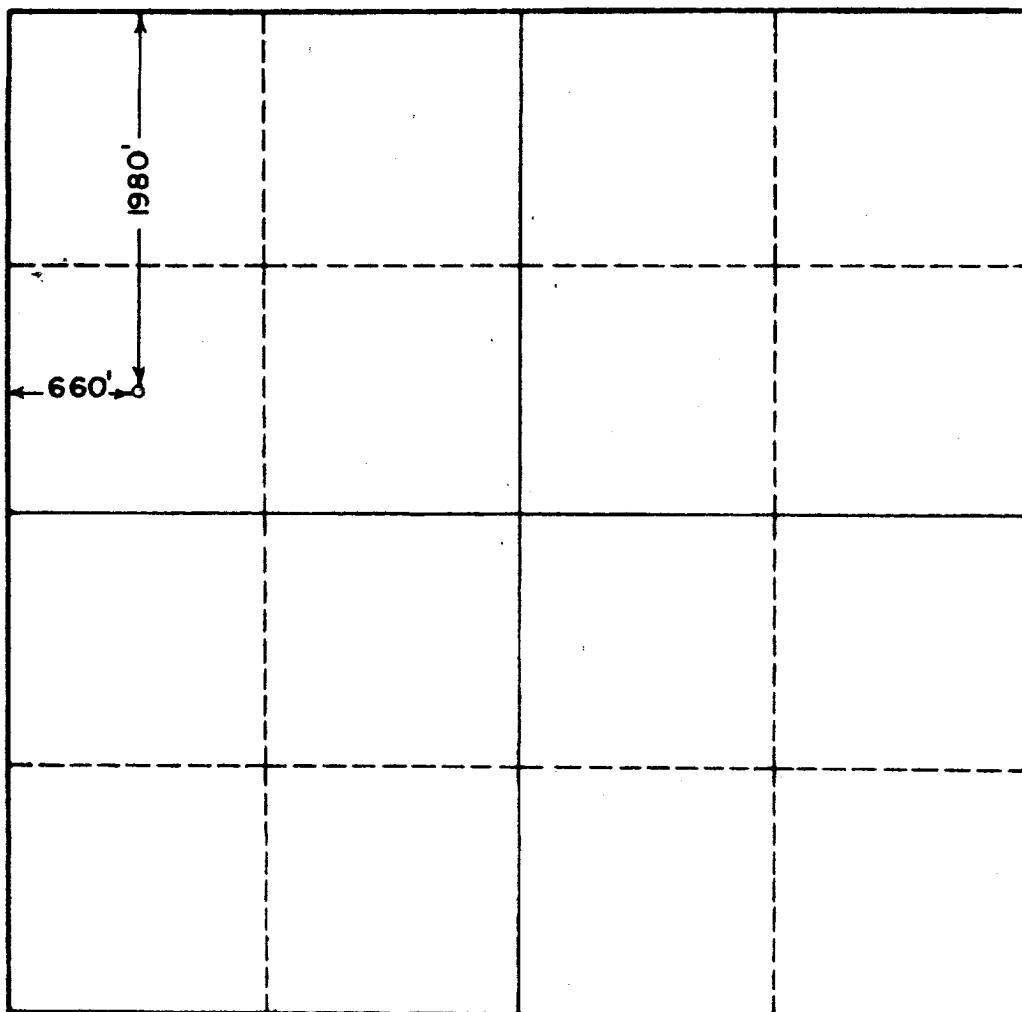

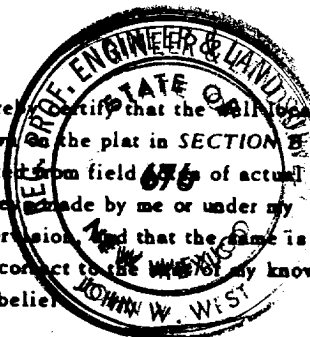
