This well tested 25 barrels of water per day from perforations at 3838 to 48'. We propose to set a drillable cement retainer at approximately 3815' and squeeze perforations at 3838-48 with 50 sacks of cement. We will then drill out plugs and perforate at 3952-58, 3964-68 and 3972-76 with 2 jet shots per foot. These will be treated with 8,000 gallons of water frac with 6,000# of sand.

Instructions
