This well has 8-5/8" O.D. casing set at 4149'. Casing is perforated at 3776-3802 and 3952-76. Perforations at 3838-48 have previously been squeezed off with cement. We propose to convert this well to water injection by running 2-3/8" O.D. upset tubing internally coated with plastic. A tension packer will be set at about 3715'. Injection will be below packer.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
