Well is presently producing from open hole section 3708-3800' in the Grayburg Formation.

We propose to deepen well 120', perforate 3355-3400' in the Grayburg as follows:

Move in and rig up workover rig and pull rods and tubing. Deepen well 120' from 3800' to 3920'. Move out workover rig. Move in completion unit. Run Gamma Ray Neutron (Open Hole) log. Acidize new open hole section of the San Andres with 2000 gallons acid down 2-3/8" OD tubing, using 4" inflatable open hole packer to block old open hole section. Seal and test San Andres through 2-3/8" OD tubing. Perforate the Grayburg selectively as stated above. Isolate perfs from open hole and break down with 1000 gallons acid and sand-water free with 10,000 gallons water and 10,000 sand. Run tubing and rods and return well to a producing status.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal or a State agency, or both, pursuant to applicable Federal and/or State laws and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 14: Needed only when location of well cannot readily be found by road from the land or lease description. A plat, or plats, separate or on this reverse side, showing the roads to, and the surveyed location of, the well, and any other required information, should be furnished when required by Federal or State agency offices.

Items 15 and 18: If well is to be, or has been directionally drilled, give distances for subsurface location of hole in any present or objective production zone.

Item 22: Consult applicable Federal or State regulations, or appropriate officials, concerning approval of the proposal before operations are started.
