Convert to a water injection well as follows:

1. Run CBL to determin height of cement behind 5 1/2" casing. If necessary, will perforate and squeeze.
2. Clean out wellbore to TD.
3. Selectively perforate the interval 3050' - 3632' (OA).
4. RIH with Baker AD-1 packer on 2 3/8"(IPC) tubing and set at 3000'.
5. Inject through perforations 3050' - 3632'(OA).
