DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Run 1,916 feet of 5 1/2" O.D. - 17# casing and cemented with 50 sacks of cement preceded by 20 sacks of drilling clay. Cement was allowed 72 hours to set and plug was drilled at the end of this period. Hole was bailed dry and tested for water shut off - for 2 hours - hole was found to be dry and showed a complete water shut off.
