Dear Sir:

Reference is made to your letter of May 28, 1956, pertaining to the commingling of oil produced on your Friess lease located in the E/2 NW/4 of 30-178-31E, Eddy County, New Mexico, Fren and Premier Oil Pools.

I recognize that permission to commingle oil produced from the Fren Pool with oil produced from the Premier Pool has been granted to other operators in the past, but I find that this is not in accordance with the provisions of Rule 303 of the Commission's Rules and Regulations, and there is no provision under this rule for my granting such permission without notice and hearing.

It will, therefore, be necessary for you to make application for a hearing before the Commission as soon as possible and it will probably be to your advantage to request that the matter be heard before an examiner at our office in Hobbs.
