1. Pump 50 sack cement plug to bottom of hole through 2" EUE tubing using 10# mud to displace. Fill up 50'.
 2. Pull 1300 ft. of 5 1/2" casing.
 3. Fill hole with 10# mud.
 4. Spot 25 sack cement plug at 1300'.
 5. Spot 25 sack cement plug at 526' (Bottom of 8 5/8" casing).
 6. Put 5 sack cement plug and 4" pipe marker in top of 8 5/8" casing. Fill up 14'.
