1. Kill well with water. Cut off tbg below Mod "D" pkr (set @ 7268') @ 7289' w/chemical cutter. Let 52' of tbg cut off drop to bottom (166' of rathole available). Run tbg gun and perf 7336-68. Acidise w/1500 gal BDA and rubber balls.
2. Set Otis type F stop collar @ 2nd collar above locator sub. Swab well to flow. Clean up well and shut in.
3. Move in surf recording BHP equip. Run BHP tool. Open well to flow. SI well. Obtain built-up BHP, drawdown FBHP, stabilized FBHP, and BHP build up during test.
