Ran 2910.89' (89 jts.) 4 1/2" OD 11.60 lb. J55-8R-STC casing at 2912 ft. Cemented with 150 sx. 50/50 Incon-Pozmix S, 2% gel, 0.75% CFR-2, and 8 lbs. salt per sk, by Halliburton Company. PD 7:30 P.M. 2-19-64. On 2-20-64, ran GR/N Logs, perforated 1 jet shot each at 2201', 2205', 2632', 2634', 2673', 2675', 2677', 2851', and 2853'. On 2-21-64, fractured down casing with 60,000 lbs. sand using 1570 bbls. fresh slick water.

Instructions
