Detailed account of work done, nature and quantity of materials used, and results obtained.

Spudded well 6:00 P.M., M.S.T., 2-6-63. Drilled 8-3/4" hole to 930 feet and cemented 7", 234/ft., J-55, SMC used casing at 924 feet with 200 sq 30-30 pos cement followed by 30 sq regular neat cement. Did not circulate cement to surface. Top of cement by temperature survey was 330 feet. Re-cemented down 3/4" tubing with 130 sq cement. Circulated estimated 10 sq cement to surface. W.O.C. 7:15 P.M., M.S.T., 2-9-63. After W.O.C. for 18 hours tested 7" casing to 1000 psi for 30 minutes, O.K. Drilled 30 feet cement and tested casing and formation to 600 psi, OK.

Cementing and testing operations were witnessed by Mr. W. A. Gressett of the N.M.O.C.C. Now drilling ahead at 1080' in 6 1/2" hole.
