1. Pull rods and pump, check TD w/tubing and pull tubing.
2. Clean out to TD if necessary.
3. Run GR-N log from 2600' to TD.
4. Determine prospective intervals from logs and perforate Upper and Lower Penrose.
5. Run tubing and packer, spot across new perfs, set packer above new perfs, break down perfs w/500 gals. 3% HF and 12% HCL acid.
6. If necessary, frac in 2 equal stages of 5000 gals. GBW, separate stages w/200# rock salt, flush w/1000 gals gelled brine water. Pull packer and tubing.
7. Run plastic coated 2-3/8" tubing w/packer set @ 2850'.
8. Load annulus w/inhibited water.
9. Connect up for injection.
10. Run injectivity profile when pressure and injection rates have stabilized.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
