1. Pulled rods, pump and tubing. Ran sand pump and cleaned out 3015-3210 TD.
2. Ran GP-1 log 3219-2600'. Perforated 5-1/2" casing w/2 JSPI @ 3023, 33, 38, 2800, 16, & 20'.
3. Ran 2-7/8" tubing w/packer and RBP, set RBP @ 3050 & packer @ 3000'. Acidized perforations 3023-39 w/500 gals. 3% HF & 12% HCL acid. Had communication. Reset packer @ 2870' & fraced w/10,000 gals. gelled brine, 10,000# 20/40 sand. Reset RBP @ 2870' and packer @ 2770'. Could not break formation.
4. Fraced perforations 2806-3039' w/10,000 gals. gelled brine, 10,000# 20/40 sand. Pulled tubing, packer & RBP.
5. Ran 2-3/8" plastic-lined tubing w/packer set in 5-1/2" casing @ 2745'. Loaded annulus w/46 bbls. treated water. Pressured to 500# on casing, 30 minutes, 4-4-74. Held OK. Connected up for injection.
6. Conversion to injection completed 4-4-74.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
